The Law of Rights of Light is a new and comprehensive treatment of the controversial topic of rights of light. It considers how rights can be established, what constitutes an infringement of those rights and what remedies can be provided for the infringement of those rights. It explains how claims may be defended and rights overridden. By setting the law in its wider context, the book seeks to show that, despite the technicalities which arise, there are no legal problems with which a competent lawyer cannot grapple.

The book benefits from two technical appendices and colour illustrations provided by *Point 2 Surveyors*. The first explains how light is measured; the second how losses are valued. These appendices also explain the limits of current methodology. These limits leave current methods ripe for reconsideration by the Courts.



Sir Edward Marshall Hall KC saved more people from the hangman's noose than any other known barrister. In an age of inadequate defence funding, minimal forensic evidence, a rigid moral code making little allowance for human passion and a reactionary judiciary, his only real weapons were his understanding of human psychology and the power of his personality.

This book sets out to test the hypothesis that the fundamental concept which determines the validity and competence of usurper regimes in common law jurisdictions is the concept of legitimacy as was clearly elucidated in the Grenada Case of *Mitchell v DPP* (1986). A comparative analysis of this case in juxtaposition with sixteen other extra-constitutional common law cases comprised the main scope of the study. Consequently, an exhaustive survey of these cases beginning with the *Dosso* case in Pakistan in 1958 and ending with the *Qarase* case in Fiji in 2009 was conducted. The analysis reveals that the appropriateness of utilizing any of the judicially recognized doctrinal concepts of strict constitutionalism, state necessity, Kelsen's theory of revolutionary legality and the doctrine of successful revolution depends, inter alia, on whether there was continuity or discontinuity of the legal order of the state. These doctrinal concepts have their own implications for the concept of legitimacy following the occurrence of a coup d'etat or a revolution. Legitimacy itself has important implications for resolving various extra-constitutional issues which inevitably arise.

Dr. Lawrence Albert Joseph was born in Grenada, In 1977 he became qualified as a Barrister at Law, Lincoln's Inn, London, England. On his return to Grenada, Dr. Joseph became a magistrate (1979-84), President of the Senate (1984-88) and 2013-14), Attorney General amongst other ministerial port folios (1995-2003) and Speaker of the House of Representatives (2003-08).



The essays in this collection offer a unique contribution to these and other aspects of the use of interdisciplinarity in comparative law.




War pensions law contains a number of unique features, in particular, the onus on the Secretary of State to disprove entitlement to benefit beyond reasonable doubt. Although the war pensions scheme has now been replaced by the armed forces compensation scheme, claims continue to be made under it in respect of new conditions and in respect of deterioration in the condition of claimants already in receipt of awards.

The armed forces compensation scheme, which was introduced in 2005, proved controversial, particularly against the background of the very serious injuries sustained by members of the armed forces serving in Afghanistan, and was substantially amended in 2011 as a result of a review of the Scheme carried out under the chairmanship of Lord Boyce.
