

### AMONG THE WILD(Y) BUNCH

The first thing one notices when stepping into Wildy's Lincoln's Inn Archway shop is the extraordinary number of legal texts which have somehow been shoehorned into what is, by North American standards, a rather modest sized space. To this perception is soon added the witnessing of bustling activity in the shop: law students, barristers, judges and others making their important purchases and the staff busily tending to the needs of a variety of patrons and patron-types: those shopping in person, others on the telephone, and a veritable deluge of orders made by email and on the Wildy website.

In my normal life I am Law Librarian and an Associate Professor at the Faculty of Law of the University of Manitoba in Winnipeg, Canada. While on research leave I spent September and October of 2006 at Wildy's, engaged in a project helping to improve their database of antiquarian law books (more about those delights later). It was, to say the least, a real eye-opener for me. Like many North Americans I had a rather quaint notion of Wildy's and its business. My memories from a handful of visits there in the past were of an old and charming bookshop in which one could easily imagine Dickens browsing the shelves (which apparently is the case). Because bookshops in my part of the world function primarily as such and little else, I believed the same held true for Wildy's. I could hardly be more mistaken.

Wildy's is a unique phenomenon. It is, of course, a bookshop, but that is only a portion of the service they provide. Wildy's is very much a full-service purveyor of print legal information and is not confined to the mere sale of books to in-person clients. It provides subscription services to a host of large libraries and law firms, keeping their updates coming in a timely manner and managing their looseleaf subscriptions efficiently and effectively. It is an international distributor of legal materials. One cannot help but be impressed by the cartloads of boxed materials leaving the premises every evening for legal information consumers in all parts of the globe. The orders for these materials are received by web order, email, telephone, and post. Furthermore, it is even a producer of legal information through its publishing wing, Wildy, Simmonds & Hill.

In my library our acquisitions are made directly from the publishers from whom we purchase and there are, to my knowledge, no bookshops in Canada who could replicate what Wildy's does. Therefore I was surprised by the volume of their business and the large number of clients who prefer to make their purchases through them and not deal directly with the publishers. After observing their operation for a few weeks, I began to understand this state of affairs. The simple fact is that Wildy's can provide complete service to their clientele, something which the publishers cannot. They are not tied to one publisher's catalogue and therefore can give objective and balanced advice with regard to a patron's information needs and they do everything in their power to get the material ordered to their patrons immediately and at minimal expense.

Given that space is, as mentioned earlier, quite limited, Wildy's cannot devote a great amount of space to storage of inventory. Therefore they very much have to anticipate their clients' demands and remain nimble enough to respond quickly to them. This requires a great amount of expertise and knowledge in the field. I have constantly been impressed by the high level of these demonstrated by the Wildy's staff all of whom have worked in the field for a goodly number of years and one of whom is even a LL.B. graduate and particularly expert in advising students about to embark on legal studies or already involved in their pursuit.

An unfortunate misperception of Wildy's – likely a result of their having been around since the 1830s – is that they are a "second-hand bookshop". The fact is that they do sell second hand materials at reduced prices and they do have a wonderful collection of antiquarian law books, but these comprise only a percentage of their overall business. In fact, ninety-five percent of their annual turnover is comprised of new books, subscriptions, and library services.

The antiquarian collection, with which I worked for two months, is a most impressive collection of historically significant and important works. As a Canadian law librarian, I was very much aware of many of the titles and series held at Wildy's and I was very much like the proverbial "kid in a candy store" to be surrounded by these delightful works. Actually touching and gently leafing through a mint condition first edition of Blackstone's Commentaries one cannot help but feel connected to the grand sweep of legal scholarship which has informed the law in the entire legal "Anglosphere".

I enjoyed my time at Wildy's immensely. I would be remiss if I didn't mention the delightful company of my colleagues there. They were to a person hard-working and dedicated yet possessed of a good sense of fun and humour and it was a delight to spend time in their midst

Two months at Wildy & Sons was a revelation. It is not, by any means, just a legal bookshop. It is a much more fulsome operation capable of satisfying the legal information needs of a vast array of clients anywhere in the world. Should they remain as responsive to the needs of their patrons and as adaptable to new technologies as they have so far demonstrated, I am confident that they will prosper for many, many years to come.
