Furthermore, in the aftermath of leading cases such as White and Miller & McFarlane, many high net worth spouses are keen to minimise the share to which their ex-spouse might be entitled in the event of divorce, and are therefore increasingly using pre-nuptial agreements. In Charman last year, the President of the Family Division raised the question whether parties to a marriage should have the opportunity to order their own affairs by a pre-nuptial agreement.
