Epilogue

The eruption disruption - Lost in Africa or, I'm a Company Director, get me out of here!

As the Conference drew to an end, my colleague Steven Ross prepared to return home the following day whilst I flew down to Lagos planning to fly back to the UK on the following Friday. At some point during that week I received a text from Steve saying he hoped I was not delayed by the volcanic eruption? Blissfully innocent to what was going on in Iceland, I replied that I was sitting on the roof of a building watching the lava flow beneath my feet – little did I know the actual situation!

I had checked into the Sheraton Hotel in Lagos which was close by to the airport expecting to fly back to England the following morning, then I switched on the television and the truth of the situation suddenly dawned on me, there was no way I was going anywhere for some time. I was effectively trapped in the hotel as going outside the compound on my own was basically unsafe. I sat it out for the next few days, whilst racking up huge accommodation bills. Everything was so expensive there. On one occasion I went down to the bar and ordered a club sandwich and three small whiskies over a period of two hours, the bar bill came to £32! I was rapidly running out of cash, though fortunately the hotel did except credit cards.

I kept in touch with London by text and email, but was becoming slowly stir crazy and worried about the increasing costs of my internment. On the Tuesday I telephoned London to say I was becoming desperate and somehow, someway needed to get out. The solution, however bizarre it might sound was to fly to New York for a few days and sit it out there. It was actually cheaper than to stay at the Sheraton with their sky rocket prices! Having received my e ticket and being assured by the airline I could pay for this by credit card, I checked out of the hotel and headed to the airport. When I arrived at the airline desk I was informed that they would only accept a cash payment and clearly the \$100 I had left was not going to be good enough! Catching a taxi at dusk outside the airport is quite a scary experience and not something to be recommended, but I had little choice. Two hours after checking out of the hotel, I was back in reception – they seemed delighted to see me!

Back in my cell (hotel room) I received a call from Steve Ross who informed me that the skies had dramatically been reopened and he provisionally had got me a seat on a BA flight back to England. The following morning I received a cash transfer via Western Union and paid for my flight via a local agent. This after receiving an escort from the head of hotel security who was concerned about my walking to the bank on my own and insisted on coming with me.

So I now had my ticket back home and some dollars in my pocket, things were finally looking up. When I arrived at Lagos Airport the place was like a zoo with huge Disney-like queues of mainly Nigerian people trying to get on the flight to London. It was instantly obvious that even with four hours to spare, I'd never make it to the check-in on time. A large Nigerian appeared and said 'let me take your bag', and you can imagine my response! He insisted that he could get me through and given that he could have hardly run away due to the crowds, I hung on to the back of his shirt as we forced our way to the other end of the airport. He then proceeded to ignore the snaking queues and we headed in a straight line ducking under the barriers. There was so much shouting going on that no one seemed to notice and we finally approached the check-in desk. 'Give me your passport' he said and with some reluctance I did. He then handed it over to an associate on the other side of the barrier. With one eye on my suitcase and another on my passport I stood and waited. After what seemed like forever, and me doing an excellent impersonation of a human shower due to the intense heat, I was beckoned towards the first of many security checks. My luggage was searched but it was clear that I wasn't going any further until I had observed a local tradition of giving the attendant some payment for the privilege of going through my dirty underwear. The transaction concluded

I was then able to check in quite normally apart from my two new found Nigerian friends in attendance. We then went off to 'discuss the unfinished paperwork'. This involved \$50 each to them and a further \$100 to an unseen accomplice who had obviously turned a blind eye to what had been going on. I then proceeded to passport control to discover even longer queues. By that time all convention had gone out of the window, so I walked straight up to the fast track desk reserved for first class and business and to my great relief was waved through with my economy boarding pass. I had finally made it airside. I was soaking wet with perspiration and very agitated. It was something of a minor 'Indiana Jones' experience I can assure you. One final twist was in the departure lounge. The man behind the desk began to gleefully scratch out my allocated seat number and write a new number on it. 'Please don't do that,' I shouted. 'That's my seat and I want it'! He handed it back to me and whispered simply 'you have been upgraded to Business Class'! A very pleasant outcome after a very traumatic few days. The next thing I knew was being woken up in London, after we had landed; I had made it back home!

On an August evening in 1928 May Donoghue, a shop assistant, entered a café in Paisley. The circumstances of her visit made legal history. A ginger beer was ordered for Mrs Donoghue who famously complained that, to her surprise and shock, a decomposed snail had tumbled from the bottle into her glass. Mrs Donoghue sued for the nervous shock she claimed to have suffered as a result. The question whether she had a case in law against the manufacturer of the ginger beer was argued as far as the House of Lords. It is hard to overstate the importance of the decision in Donoghue v Stevenson. It represents, perhaps, the greatest contribution made by English and Scottish lawyers to the development of the common law.

Donoghue v Stevenson made it clear that, even without a contract between the parties, a duty of care is owed by 'A' to take reasonable care to avoid acts or omissions which could reasonably be foreseen as likely to cause injury to his neighbour: 'B'. This concept, developed by the great jurist Lord Atkin, has become known by the universal shorthand, 'the neighbour principle'. Who, Lord Atkin asked rhetorically, is 'in law' my neighbour? Donoghue v Stevenson provides the answer.

The Snail and the Ginger Beer tells the full story of this remarkable case. It provides vivid biographical sketches of the protagonists and of the great lawyers who were involved in the case. It sets Donoghue v Stevenson in its historical context and re-evaluates the evidence. The roots of the neighbour principle are excavated in the parable of the Good Samaritan and the case law of the United States. The constitutional importance of the case is also dealt with; the blow it struck for a moral approach to the law which departed from a rigid doctrine of precedent. Finally, the book investigates the influence of Donoghue v Stevenson across the common law world: from the USA to the countries of what is now the Commonwealth






