John Sinkins' Cares 4 Kids Cycle Challenge Costa Rica Diary



Saturday 30 October London to San Jose, Costa Rica via JFK (9690km - verified by Google!!)

The day started very early at 05:30 as we assembled at London Heathrow and a long day of travelling lay ahead. 14 cyclists were on the trip, 12 cyclists were veterans and it was great to meet up with them again and this year we had two new 'virgin' cyclists - David Ridley and Rick Callaghan. I didn't see David as he had checked in early and already cleared passport control and security.

We flew first to New York and assembled there for the onward journey to San Jose, I still hadn't met David, but I did notice a strange casually dressed character hovering near the group who might easily have been a friendly plumber? Both flights were relatively uneventful and we arrived in San Jose, Costa Rica at 2 am Sunday morning (GMT). We assembled again and to my surprise the happy plumber was still with us. I was even more surprised when he climbed on the bus with us for our two hour transfer to Hotel Suerre in Guapiles – was he lost? All was revealed when I discovered it was in fact our 'missing' virgin, David Ridley! My apologies David, but it did seem very funny at the time!




Sunday 31 October Guapiles (20km)

Despite us having been up for over 24 hours, jet lag meant we were awake at 07:00 and first thing we set up our bikes and introduced our team mascot teddy to the team, complete with its own cycle shirt and raincoat. This was not an official day of riding but we set off on a short circular route of 20km to warm up our legs and acclimatise to the heat and humidity. Brian Harding entertained us with music from his iPod as we cycled along and he was also the first casualty falling off his bike as we finished. It wasn't too serious but unfortunately as Brian was our main cameraman we didn't catch it on film and rather unsportingly he refused a 'take two' invitation so that we could!

Monday 1 November Guapiles - Puerto Viejo de Sarapiqui (75km)

We all lined up for a group photo wearing our Costa Rica Cycle shirts sponsored by Northern Rock and were also handed our travel first aid kits sponsored by Aegon. We then set off at 07:30 for our first full day of cycling alongside miles and miles of banana and pineapple plantations. This was to be a serious initiation as it involved a great deal

of tough 'rough road' cycling. We headed north on the main road and after 20km turned off onto rough dirt tracks. This was also bandit country where we were advised to cycle in pairs to reduce any risk of being stopped by bandits who wanted to steal our bikes. The heat and humidity was intense and we were drinking huge quantities of water to remain hydrated. During the second stint of the morning, big Mo Rasool came along side and asked if I was alright? I said I was fine but he stayed with me and after a while insisted we stop. Despite Mo's size I realised I was having difficulty focussing on him and he insisted that we wait for our team doctor Mansur Halai. The Doc advised me to sit on the support bus as I was clearly dehydrated and with some reluctance I climbed aboard to find one rider already there and by noon there were four of us on the bus all suffering from the heat and humidity. Lunch was a picnic at a small infrequently used building that was playing great 80's music which kept us entertained trying to guess the next classic track from that era. By now the temperature was in the 30's with 100% humidity - it was so hot but we cycled on taking unplanned breaks to cool down in the shade and take on fluids. Once we restarted it was like cycling in a sauna. We eventually left the dusty dirt track and to our delight and were blessed with smooth(ish) tarmac until we reached the rustic Hotel Gavilian which was set back in the rainforest jungle. The cold showers were so welcome to help us cool down and wash of the dirt and grime of the day. It had been a tough day for us all and David Ridley was nursing a training injury and dug deeper than most to finish with a punch in the air - well done David!





Tuesday 2 November Puerto Viejo de Sarapiqui - Muelle de San Carlos (75km)

Today some early risers (05:30) amongst the group enjoyed the cool morning sun breaking through the jungle vegetation and the dawn chorus of woodpeckers and beautiful coloured birds was truly amazing. We set off today at 07:30 again (this was the plan for the entire week) but not before a warm up session led by Andreas Moench (Aegon) and his loud rallying cries of 'think of the kids', a phrase we repeated quite often during the week as the challenge became more arduous! We headed off on the main road towards San Miguel accompanied by juggernauts that rumbled past us en route from Panama to Nicaragua. After 12km we turned off the main road on to a dirt track and steep hills. Tex Nagra, with legs of steel pushed on ahead of us up the hills to capture us on film puffing and panting as we climbed the hills!

We continued to keep focused as the law of 'Size Matters' came to the fore as the tractors and trucks rumbled dangerously close past us. It was a very long morning, clocking up more than 55km before lunch in the scorching heat. Somewhere along the route, Brian Harding managed to fall of his bike again and his right leg was badly grazed, he joked that he wanted to match the scars on his left leg from the previous day! Lunch was in a typical Costa Rican roadside restaurant, consisting of meat, rice, refried beans and plantain. It hit the spot after another tough hot morning, but as we recharged the batteries the heavens opened - torrential rain, thunder storms and lightening battered the corrugated iron roof and our bikes outside. We watched trucks skid past as they reached the junction outside the restaurant. This didn't look good at all for the last 20km of the day. At 15:30 we made the decision to call it a day as it was too dangerous to continue - the conditions had not improved and visibility was so poor that our safety became the No. 1 priority. So reluctantly we climbed aboard the support coach to drive to Hotel Tilarjari. The rain continued into the night and lasted for almost 13 hours - well we were in the middle of the rain forest and it was the rainy season! Fortunately we had all remembered to pack our rain gear!

Wednesday 3 November Muelle de San Carlos - Arenal (54km)

Bags packed we all met for breakfast at 06.15 to be treated to a bird display – their colours were amazingly striking and the backdrop of a fast flowing river with the lush jungle beyond was like nothing I had ever seen before. Everyone seemed motivated and ready to go on this the 3rd day of our cycle challenge, despite the daunting prospect of knowing we had to climb 3000ft towards the active Volcano Arenal - probably the most active volcano in the world. And (as past readers of my cycle challenges may remember) I don't do hills!

The rain had finally stopped however and that made the air sweet and fresh. It was obvi-





ous everyone had a spring in their pedals in this lovely air, after the stifling heat of the previous day. Following a gentle start with a stop to view giant dinosaur like lizards (Iguanas) by a river, things soon turned challenging. We had hills that continued forever - Sam Tesch (our feisty leader) chatted away and before we knew it the miles had burned away and we were at our next break - the town of La Fortuna. This was a shopping opportunity for some; others cooled their burning feet in a convenient fountain, or simply chilled out at a local cafe, ready for the next leg.

The super fit cameramen duo in Tex and Brian worked incredibly hard as they raced ahead of the others to catch us on film - except for the equally fit Andreas who is never to be seen as he disappears in a cloud of smoke. As always, when things got tough the team spirit is amazing and kept everyone moving and I even managed to conquer the hills. Our team Doc (Mansur) and Tour leader (Miriam) were always at the back of the group, gently but firmly keeping things moving at a pace. The scenery was spectacular this day with mountains, volcanoes and lush vistas. After a very step final climb partly off road we were rewarded by finishing at Hotel Linda Vista with stunning views of the volcano and Lake Arenal. This was the best day of the challenge so far – what would be in store for the next?

Thursday 4 November Arenal – Tilaran (70km)

We woke to a wonderful clear view of Volcano Arenal which was venting plums of white smoke into a perfect blue sky. We headed west cycling around the beautiful Lake Arenal to Tilaran with amazing views of the lake and mountains. We retraced our path along the rocky road we had cycled the previous day and the temperature rose rapidly, but luckily we were protected from the sun by the tall trees on either side. The first challenge of the day was a loose downhill section just before a dam that crossed the easterly edge of the lake. This downhill section saw a number dismount their bikes and walk down to the dam. Jo Reed's bike with its slick tyres wasn't able to keep traction and she fell, causing three men to come running to her rescue. This was also the first time Doc Mansur had been called on and he quickly bathed her wounds and applied plasters, Jo was incredibly brave – most men would have made a huge fuss!

The rest of the day consisted of long undulating climbs and down hills on smooth tarmac around the edge of the lake. However, Mo broke another chain and had to wait for a replacement bike – it made us question whether he was trying to notch up 10 bikes rather than 10 challenges!

Just before lunch the heavens opened and we were caught in torrential rain – those who had planned for rain were able to change into dry clothes for the long afternoon stint, whilst the others tried to ring out most of the water. The skies darkened and it rained again in the afternoon. It was a wet and cold end to the day as we cycled past partially blocked roads where there had been mini landslides – how little at the time did we know of what was happening elsewhere in Costa Rica.

We were staying at the only hostel in Tilaran and the rooms were so basic (and not particularly clean) – it was clear we were going to struggle to dry our clothes. It was that evening that we heard about the fatal landslide south of San Jose and the conditions along the pacific coast. Twenty six people had been killed as Costa Rica was hit by the tail of the hurricane that had been lashing Haiti. Our tour leader Miriam suggested the technical 'off road' route, over rivers and streams, on our last day might need to change, as the condition of the paths would have deteriorated. We agreed to make a decision at breakfast the following morning when we would hopefully know more.

Friday 5 November Tilaran – Bebedero (39km)

Today we were up at 06.00 ready for breakfast and see how things had progressed with the weather conditions, but first we had to celebrate Devesh's birthday, with a card, banner and a song. Miriam met with Sam to discuss alternative routes for the day – we had planned to cycle 45km to Las Juntas over rough roads but this changed to a tarmac route to Bebedero; just 4km shorter than the original route because many of the trails had been

washed out.

We cycled together in a tightly packed peloton as large trucks, transporting bulldozers and diggers, rumbled past us as they attempted to clear and repair roads along the pacific coast. As we got closer to Bebedero, a small simple village on the edge of the river, the fields either side of the road were flooded. It was difficult to know which were rivers, fields or lakes. We reached Bebedero in good time and celebrated our success with the support team who sprayed us with sparkling wine under a banner of Foundation balloons.

It was a great feeling knowing we'd finished a tough challenge (most of us stronger than when we started) having cycled in all weather conditions and over all forms of terrain.

Two key phrases came to the fore during the week - 'Live the Dream' and 'Think of the Kids' - they motivated us when we were feeling low and bonded us as a team.


This team was a group of very special people with great camaraderie and it was a pleasure cycling with all of them. I have to make a special mention to Mo Rasool who has now completed his 10th cycle challenge and whilst he's said it's his last – he's a young, fit, gentle giant and we're hoping we can persuade him to come back again next year!
