

Abel, Richard L., Lawyers on Trial: Understanding Ethical Misconduct, Oxford University Press USA, Hardback, £45.00, ISBN: 9780199760374

In Lawyers on Trial, Richard L. Abel presents the stories of ten California lawyers who broke the rules: hiring an ex-cop to chase ambulances, flouting fee limitations in medical malpractice cases, creating a fictitious company and impersonating non-existent people in order to appropriate Sega's computer games, a former California

Real Estate Commissioner defrauding developers and financiers, helping a represented co-defendant negotiate a plea without his lawyer's participation or knowledge, and defying a judge's sealing order and his own client's wishes for closure in order to champion the "defenceless" and "oppressed" and protect "widows and children." The book begins by showing how nearly a century of political struggle over selfregulation shapes the way the disciplinary system selects and processes cases and concludes by canvassing reforms that could improve the performance of the legal profession.



ISBN 9781841132228. £60.00, due March 2011 In an age of globalisation, many regulatory problems lie beyond the reach of the nation state Solutions have to be found which extend beyond territorial borders. Normally we would expect international law to be the appropriate forum for addressing these issues, but this assumes formal consensus amongst states, which is difficult to obtain. Therefore a number of informal structures of pragmatic public governance have emerged as an alternative to formal law-making processes, operating within the transnational space between national and international law. These structures display a great variety-ranging from loose transboundary networks linking national administrative agencies and transnational expert committees, to networks involving administrative staff of international organisations. They work out their own agendas, and in some cases have emancipated themselves from formal national or international parent institutions. These network-like structures have become important building blocks of global governance, addressing today's regulatory issues in a more flexible way. At the same time their informality raises crucial questions of legitimacy.

The present volume shows how transnational administrative governance leads to a paradox: while it performs well in many areas, providing solutions that are not achievable by state and international law, its informality profoundly lacks legitimacy in a strict sense. 



The statutory provisions on drink-driving are set out in just fifteen sections of the Road Traffic Act 1988, and two from the Road Traffic Offenders Act 1988, but there have been over 700 appeals to the Divisional Court on points of law since the Acts came into force. The result is a body of law which is technical and complex, covering a wide array of matters.

The Drink-Drive Offences provides a practical, comprehensive, accessible and up-to-date account of this broad and intriguing area of law. It traces the procedure from preliminary testing to penalties, taking the legislative provisions in sequence and explaining the effects of the case law. The routines for preliminary testing, and for requiring and analysing specimens of breath, blood or urine, are examined. This includes the recurring question of the reliability of the breath analysis instrument and the circumstances in which a blood or urine specimen may be required instead of a breath specimen. The constituents of the offences are explained, in chapters on the excess alcohol offences, the offences of being in charge, the offences of being unfit to drive, and causing death by careless driving when under the influence of drink or drugs. The statutory assumption that the level of alcohol at the time of the offence was no less than in the specimen receives special attention, along with the "hip flask" defence, where the motorist asserts that it was alcohol consumed after driving which accounts for being over the limit. A chapter is devoted to the offences of failing to co-operate with preliminary tests and failing to provide specimens, with full consideration of what constitutes a "reasonable excuse" for these purposes. Finally, the penalties are set out, including special reasons for not disqualifying.
