Criminal Law Week's bi-annual supplement is another highlight. Digests on other items such as miscellaneous amendments to sentencing guidelines and updated versions of the Attorney General's Guidelines on Disclosure, Crown Court Compendium, King's Bench Guide, Youth Court Bench Book and Equal Treatment Bench Book are also included.

There are also plans for a Better Buses Bill. There will be coverage of Bills when enacted.

There was also a commitment to an Equality (Race and Disability) Bill to extend the principle of equal pay to those protected characteristics. Coverage will be given to the change with the greatest impact from the proposals amendments to the right not to be unfairly dismissed. Other statutory changes include that the Neonatal Care (Leave and Pay) Act 2023 is expected to come into force in April 2025. In view of Labour manifesto promises to 'ensure a phased and responsible transition in the North Sea that recognises the ongoing role of oil and gas in our energy mix,' to 'embrace the future of energy production and storage which will make use of existing offshore infrastructure,' and not to revoke existing licences, but 'to manage our existing fields for the entirety of their lifespan,' significant legal changes to the petroleum production regime are not to be expected, though the undertakings not to grant any new licences, and to ban fracking, will be noted up along with any associated legislative change.
