
The book explains what a political donation is – the scope of the relevant law is much wider than simply contributing to party funding – and who is permitted to be a donor. It looks at the requirements on companies, and when those requirements are triggered and explores the powers of the Electoral Commission. It also examines the relationship between the legislative framework affecting political donations and Parliamentary rules on the acceptance of gifts and sponsorship, and describes how the Bribery Act 2010, due to be brought into force in April 2011, will apply to political donations. A separate chapter provides an overview of relevant international instruments, of the law on political funding in the United States, and of European Union rules.

The Political Parties, Elections and Referendums Act 2000, the Electoral Administration Act 2006 and the Companies Act 2006 are all covered. The authors also examine the impact of the Political Parties and Elections Act 2009, which aims to ensure greater transparency regarding political donations and reinforce the arrangements for regulating candidate expenditure.



*The Law of the Manor* is the definitive work on the subject, providing detailed, up-to-date and comprehensive coverage for lawyers and also to those owning, managing, selling or buying historic houses and estates. It provides a modern description of the law associated with lordships of the manor. Principally concerned with the lands and rights of the lord, the book also considers rights that tenants of the manor can claim against him. These are put in context with a discussion of associated topics such as franchises and titles of nobility.

The second edition has been updated to cover numerous developments in the law since 1998, in particular the Land Registration Act 2002, the Countryside and Rights of Way Act 2000 and the Commons Act 2006. The book includes changes made by the Hunting Act 2004, the House of Lords Act 1999, and the Legal Services Act 2007 as well as the relevant case law. New material has been included on escheat, rectorial manors and roadside verges. There is also greater coverage of legal authorities especially in the eighteenth and nineteenth centuries and a selection of useful precedents for the practitioner. Although the book is about the law of the manor in England and Wales, there is some reference to other jurisdictions, most notably the experimental extension of the manorial system to some American colonies.

The text is arranged in five parts. Part 1 describes the context, summarises the history and analyses custom which is the basis of manorial law. Part 2 describes the lands of tenants and lords and the relations between them. Part 3 discusses rights and comprises a detailed commentary on section 62(3) of the Law of Property Act 1925. It covers rights of common, mineral and sporting rights, courts and remaining revenues. Part 4 sets the manor in the context of other institutions, namely the village, the church, towns and feudal relationships. Part 5 summarises and looks at the modern manor, its documents, conveyancing (with particular reference to registered land) and taxation, concluding with suggestions for reform.

*Wildy's Handbook for Magistrates* (previously published as *Blackstone's Handbook for Magistrates*) is a readable and comprehensive account of the work of magistrates in England and Wales. It examines how magistrates are appointed; what they are empowered to do; how their courts are organised and operated; the kinds of matters they deal with – crimes such as theft and assault, traffic offences and issues concerning children and families; how they go about assessing evidence and deciding what to accept as true; how they decide whether defendants should be released on bail or kept in custody; the sentences they may impose and how they endeavour to make the punishment fit the crime. The book also looks at how legal aid works, a subject of continuing public and political concern. Last, but not least, it gives a flavour of what life as a magistrate is really like, touching on the pressures, responsibilities and rewards of the work.

This new edition reflects the many changes introduced over recent years. These include revisions to the procedure for applying to become a magistrate and the training requirements; the introduction of the Criminal Procedure Rules, case management and other measures to reduce delay; the landmark Courts Act 2003; amendments to the Bail Act 1976; and wholesale revision of the approach to sentencing.

The authors, one a deputy justices' clerk, the other a serving magistrate, bring two different, but equally important, areas of experience and expertise to the work and explain complicated concepts in a straightforward manner, keeping legal jargon to a minimum.





In comparative legal studies, the concept of legal culture has come to play an increasingly significant role in contemporary theorising, empirical analysis and methodological innovation. This book, entitled *Using Legal Culture*, explores a number of the key issues regarding the use of this concept.

The essays contained in this book were originally presented in the *Journal of Comparative Law Workshop* held in Venice University (Ca' Foscari) May 20-21, 2010. 

What do Prince Charles, Bette Davis, Sir Ian Botham, Mrs Victoria Gillick and a man whose family grave appeared in the background of a splatter horror film have in common? Each of them felt they had been wronged in some way, and each went to court to try and do something about it. Sometimes their case was a purely private argument. Others brought cases of national importance, or claims which raised acute moral and ethical principles. Some won handsomely, while others lost so badly that they ended up far worse than when they started. This new book looks at fifty legal disputes from Victorian times to the present day, where a compelling moral or legal issue was at stake, or where the background to the case was interesting, amusing or infuriating. It begins with three Victorian murders, including the law student favourite of *R v Dudley and Stephens*, the case of shipwrecked sailors eating the cabin boy and later facing trial for his murder. It then covers cases ranging from the early days of Hollywood and both world wars, through to modern day battles over superinjunctions, MPs' expenses, the vexed relationship between religion and law, and the sometimes hazy relationship of law and sport. Written in a clear, accessible style, free of legal technicalities, the book will be of interest not simply to lawyers but to anyone interested in stories of great human interest and how the legal system tried to deal with them.

James Wilson graduated BA/LLB (Hons) with a Senior Prize in Law. He practised in both New Zealand and London, primarily in commercial litigation, before joining LexisNexis. He has written a number of articles for legal journals and websites, including the New Law Journal and Criminal Law & Justice Weekly.
