

The Incorporated Council of Law Reporting for England and Wales (ICLR) was founded in 1865, by the Inns of Court and the Law Society, on the recommendation of a committee of lawyers who were fed up at the erratic and disorganised way in which critical precedents were then being recorded.

From the start it has been “making case history” by recording for posterity those cases which have changed or clarified the law, or were for some reasons “peculiarly instructive”.

This book, published to mark the ICLR's 150th anniversary, collects together for the first time the top 15 cases published in *The Law Reports*, as voted for by readers on its website, and discussed by Lord Neuberger of Abbotsbury, President of the Supreme Court, in a speech given at the launch on 6 October 2015.

They include such favourites as the one about the Carbolic Smoke Ball, the one about the Snail in the Ginger Beer, and the case that gave rise to the mysterious legal concept of “Wednesbury unreasonableness”.

On a more serious note, the cases demonstrate how the relationship of the judiciary and the government has changed over time, with judges now much more likely (as in the so-called “Belmarsh case” of 2004) to defy the attempts of a home secretary to detain foreigner of hostile intent without trial, than they were in World War II, when it was the lone dissenting voice of Lord Atkin who declared “that the judges are no respecters of persons and stand between the subject and any attempted encroachments on his liberty by the executive”.


Among the other cases selected by ICLR's readers are key decisions on a company's “veil of incorporation” as a separate legal person, the “golden thread” of the presumption of innocence in criminal law, the creation (by one Denning J) of the doctrine of promissory estoppel, the reversal of the marital rape exemption, the surgical separation of conjoined twins, and the rule permitting resort to Parliamentary papers to resolve statutory ambiguity.

Introducing the cases are a series of essays by ICLR editors and by two external contributors, Guy Holborn, Librarian of Lincoln's Inn and Professor Paul Mitchell, of UCL. In his foreword, Lord Thomas of Cwmgiedd CJ says:



In 1951 Tibet was incorporated into the People's Republic of China by the Seventeen Point Agreement. Today the legal status of Tibet remains a matter of contention between the PRC and the Tibetan-Government-in-Exile. Both rely upon on legally ambiguous British engineered treaties to make their case. The inconsistent representation of Tibet's status in treaties is not, however, a reflection of the ambiguity of Tibet's status itself; it is a reflection of the ambiguity of such treaties in the context of the positivist-colonial encounter.

Drawing upon British Government archives, this book examines the issue: to what extent, in what ways, and with what effects has the British imperial legacy in the region converged with Chinese formulations of law and governance in Tibet to prejudice understanding of Tibet's legal status. This addresses a significant gap in international legal literature, which seldom discusses Tibet outside of considerations of minority rights within the PRC.

This book argues that an assessment of imperialism and its relationship with nineteenth century international law is essential to explaining the events of 1951, but it is only through a reassessment of the postcolonial that the absence of discussion of Tibet's status in international legal discourse can be explained. The history of Tibet's legal status highlights contradictions embedded within modernity and exposes the mythological foundations of the modern secular state's narrative of progress.

Manufactured Obscurity concludes that the much emphasised clash between Western and East Asian values in the field of international law in truth operates along a much narrower divide than might be presumed. This is best assessed as a reflection of the contradictions inherent to the postcolonial within international law; involving both a pushing away of the imperialistic past and a reaffirmation of its continuity in order that modern commitments to the rule of law retain value.





Why are court cases such a fertile source for writers of fiction and non-fiction alike? 



Many thousands of people are prosecuted each year for drink and drug driving offences. The legislation favours the prosecution in a number of ways, for example, by requiring those under investigation to give evidence against themselves in the form of specimens of breath, blood or urine,

but also affords certain safeguards to suspects. The conviction rate is exceptionally high, and the provisions have given rise to a wealth of case law.

Drink and Drug Drive Case Notes comprises summaries of the many cases on drink driving, and the fewer cases on drug driving, which have come before the High Court, the Court of Appeal, the House of Lords and, in one instance, the Supreme Court. Over six hundred judgments are summarised. Each note is presented as a short statement of the facts of the case, the question(s) put to the appeal court and an extract from the judgment. This third edition includes notes of some seventy-five cases decided since the second edition was published. Themes running through the new cases include the interpretation of the provisions on reasonable cause to believe that the breath analysis device has not produced a reliable indication of the suspect's breath alcohol level, and on the application of the Criminal Procedure Rules to proceedings for drink and drug driving. At the time of publication, the so-called "statutory option" has just been removed, and section 5A of the Road Traffic Act 1988, creating new offences of driving, attempting to drive, and in charge, with a concentration of a specified controlled drug above a specified limit, has come into force. The offences are framed in much the same terms of the excess alcohol offences, but testing will be by the analysis of blood or urine only. While much of the case law concerning drink-driving will be relevant, the new provisions will no doubt give rise to their own body of case law in due time.

Drink and Drug Drive Case Notes was first published, as *Drink Drive Case Notes*, as a product of collaboration between Lion Laboratories – the manufacturers of much of the breath-testing equipment used in the UK and throughout the world – and the author. This expanded and updated edition of *Drink and Drug Drive Case Notes* will prove a useful reference for police, prosecutors, defenders and legal advisers.
