
On 16 December 1966 the United Nations adopted the International Covenant on Economic, Social and Cul-


Emmanuel Levinas' re-formulation of subjectivity, responsibility and the good has radically influenced

In this volume, political theorists, philosophers and legal scholars critically engage with this idealization of Levinas' ethics. The authors show that his crucial formulation of the idea of 'the other in me' does not offer a quick cure for today's nationalist, racist and religious divides. Nor does his notion of anarchic responsibility provide immediate relief for the agony of dealing with matters of life and death. The book begins with an analysis of the wide range of choses recognized by English law, and a consideration of their distinct features. It goes on, after a brief historical overview, to consider the various ways in which English law gives effect to assignments. The effects of valid

and invalid assignments are set out, and choses that cannot be assigned described, as well as the difficult question of priorities. Thereafter, assignment is considered in particular contexts (security and insolvency) and the specific rules applicable to the assignment of particular choses are gone through (shares; insurance contracts; intellectual property; documentary intangibles). Lastly, assignment is dealt with in the context of conflict of laws. volume in the Oxford-Norton Rose Law Colloquium Series, which was held in St Hugh's College, Oxford, on 22nd-23rd September, 2006. As with past colloquia, this brought together practitioners (solicitors, barristers and Judges) and academics to examine and discuss an area of commercial law. The belief underpinning all the colloquia has been that the sharing of views on central topics of commercial law can only work to the mutual advantage of both academics and practitioners. The topic chosen this year was Contract Terms which is a topic of everyday importance to all commercial lawyers. French law, like the law in a number of American states,

ties the definition of murder to the presence or absence of premeditation, unlike the law in England and Wales. Unlike most other jurisdictions, German law makes the killer's motive, such as a sadistic sexual motive, relevant to whether or not he or she committed the worst kind of homicide. England and Wales is in a minority of English-speaking jurisdictions in that it does not employ the concept of 'wicked' recklessness, or of extreme indifference, as a fault element in homicide. Understanding these often subtle differences between the approaches of different jurisdictions to the definition of homicide is an essential aspect of the law reform process, and of legal study and scholarship in the criminal law. Every jurisdiction tries to learn from the experience of others, and this book seeks to make a contribution to that process, as well as providing a lively and informative resource for scholars and students.



The central question that it raises concerns the level of social security protection enjoyed by women moving throughout the Union in cases of work interruption or marriage dissolution. Women's social security protection has traditionally been based on two criteria, namely economic activity and family/marriage. Work interruptions, in particular for child-rearing, challenge the invocation of economic activity as an effective basis for social security rights. Changing social and family conditions, including the emergence of atypical relationships and increasing

divorce rates, challenge the criterion of family/marriage. Efforts have been made within the framework of the national systems of the Member States to address these challenges, often unsuccessfully. So, how successful has the European system of co-ordination, the aim of which is to provide a sufficient level of protection to migrant workers and their families, been in addressing these challenges? The book contains comprehensive discussion of the phenomenon and legal institution of social security, as well as a thorough analysis of the current state of European Community law concerning co-ordination, with a particular focus on gender. It identifies several problematic areas where solutions must be worked out and action taken. The book fills a gap in the legal literature on the social security field and will appeal to those with an interest in social security, including academics, policy-makers and practitioners.







This study examines the misuse of forensic psychiatry custody in China since the late 1950s as an adjunct means – alongside the legal authorities' more frequent use of arrest, trial and imprisonment – of punishing and silencing political dissidents, spiritual nonconformists, whistleblowers and other critics of official corruption or malfeasance. The principal questions addressed in the book are: how common have such practices been in China during the successive main periods in the country's post-1949 history; how have these repressive practices been theorized and handled under the country's evolving criminal justice system; and why have the security authorities resorted to this, at first sight, uncharacteristically sophisticated form of state repression? On the basis of extensive archival research into several decades of China's legal and psychiatric literature, the study concludes that the use of psychiatric custody against dissidents and other similar groups has been more widespread in China than it was in the former Soviet Union.
