This book provides an in-depth analysis of the common law doctrine of Forum Non Conveniens as it has evolved in the four major common law countries (UK, US, Canada, and Australia). The book also analyses the

similarities and differences of the doctrine among those four countries. It compares Forum Non Conveniens to the more rigid analogous doctrine of Lis Alibi Pendens found in civil law countries, which requires automatic deference to the court where a dispute is first filed and explains current initiatives for coordinating jurisdictional issues between the common law and civil law systems, the most important of which is the 2005 Hague Convention on Choice of Court Agreements.



This book deals with international sales of goods and covers contracts governed

by English law and contracts governed by the United Nations Convention on the International Sale of Goods. It deals with contract issues as well as with property matters and most notably addresses those issues arising out of the use of documents of title, such as marine bills of lading. In addition to the rights and duties of seller and buyer, there is substantial material on bankers' documentary letters of credit. The book not only includes commentary on decided cases, but also with standard form contracts which represent evolving trade practice. It aims to be an authoritative work and to offer a thorough and detailed analysis of extensive case law. The text also aims to give the reader a contextual understanding of the trading world in which international sales occur. New to this edition is commentary on the Contracts (Rights of Third Parties) Act 1999 as well as discussions on conflict of laws, the construction of commercial contracts and electronic documentation. The documentary letters of credit and the UN Convention on the International Sale of Goods are given extensive treatment in this edition.



The belief underpinning all the colloquia has been that the sharing of views on central topics of commercial law can only work to the mutual advantage of both academics and practitioners. The topic chosen this year was Contract Terms which is a topic of everyday importance to all commercial

lawyers. It is also an area in which academics have become increasingly interested in recent years.

The book focuses both on changes in areas of substantive law and the techniques of judicial reasoning adopted to implement the Act. The contributors therefore consider first general Convention and Human Rights Act concepts – statutory interpretation, horizontal effect, judicial review, deference, the reception of Strasbourg case-law – since they arise across all areas of substantive law. They then proceed to examine, not only the use of such concepts in particular fields of law (privacy, family law, clashing rights, discrimination and criminal procedure), but also the modes of reasoning by which judges seek to bridge the divide between familiar common law and statutory doctrines and those in the Convention. They conclude that while the Act can in many respects be regarded as having transformed the judicial role, in a number of areas its influence has been significantly muted due to the persistence of established judicial values and habits of mind.

This book examines the impact of international trade rules on the promotion and protection of human rights, and explains why human rights are an important mechanism for assessing the social

justice impact of the international trading system.



*Residential Conveyancing Manual* is a thoroughly practical guide to the domestic conveyancing process, guiding the reader expertly and confidently through the stages from first taking instructions, through to registering the transaction and other post-completion formalities. All the steps in the procedure are considered: deducing and investigating title; searches and enquiries; planning and building regulations approvals; drafting, approving and exchanging the contract; synchronising transactions in a conveyancing chain; mortgages and mortgage offers; stamp duty land tax; and pre- and post-completion routines. There is a chapter on home information packs, taking account of the Home Information Pack (No. 2) Regulations 2007. There is also a chapter on leaseholds, covering tricky points such

as the various statutory provisions which may be in play (extension and enfranchisement of a lease, the right to buy, the right to manage). The final chapter is devoted to the special considerations applying to newly built homes. A number of useful forms and documents are reproduced in an appendix. The sometimes difficult issues - giving and accepting undertakings, avoiding negligence, meeting time limits, recognising possible money laundering and mortgage fraud, and costs quotations - are all addressed, as is the all-important matter of keeping the client informed.
