RSS Feeds at Wildy & Sons

We are pleased to announce a new feature on our website, www.wildy.com. Customers can now subscribe to RSS feeds of new book information in their area of interest. To subscribe to the feeds simply click on the RSS Feeds link on the home page, and make your selection from the list of subjects shown.

What is an RSS Feed?

An RSS (Really Simple Syndication) feed is a summary of information published on a website that allows you to keep up-to-date with new content, on your own terms and without having to give your email address to the website owner. By subscribing to a Wildy RSS feed, you will automatically be sent the latest new book information from your chosen areas of interest.

How do I get it?

To start with you need an RSS Reader (also known as a News Reader or News Aggregator). This is a small piece of software that checks the RSS feeds you are subscribed to and allows you to read the information published. One of the more popular ones is FeedDemon, and you can download the free application from their website at www.newsgator.com.

For convenience you may want to combine several subject feeds in to one folder on your chosen RSS Reader. Or not, the choice is yours.

What is included in the feeds?

Details of books published within the last five weeks and scheduled for publication within the next six months are included in the feeds. We don't include books for which we do not have complete bibliographic information, such as an ISBN or price, nor do we include books for which we do not have any content information. If you don't see a book included in the feed that you know is due out in the next six months, chances are it is because the publisher hasn't provided us with a content description. As soon as they do we update the record on our system and the book details get included in the feed.

To give you an idea of the extent of the content, the All New and Forthcoming Titles feed currently contains details of over 400 new and forthcoming books.

How often is the information updated?

Constantly. We continually receive new book information from publishers, and when we do that information is entered on to our internal database from which the content for the feed is generated.





The focus is on English law, EU law and common law measures, but there is also some comparative material built in. The book will be useful in particular to practising lawyers seeking to draft, interpret or enforce the types of contract discussed, but the in-depth discussion will also be valuable to academic lawyers specialising in private international law. Written by an academic who is also a practising barrister,

this book gives in-depth coverage of how the instruments and principles of private international law can be used for the resolution of cross-border or multi-jurisdictional disputes. It examines the operation and application of the Brussels Regulation, the Rome Convention and the Hague Convention on Exclusive Choice of Court Agreements in such disputes, but also discusses the judgments and decisions of the courts in significant cases such as *Turner v Grovit*, *Union Discount v Zoller*, and *De Wolf v Cox*. Much of the book is given over to practical evaluation of how agreements on jurisdiction and choice of law should be put together, with guidance on, amongst other things, drafting of the agreements (including some sample clauses), severability of agreements, consent, and the resolution of disputes by arbitration.

grew out of lecture courses delivered under the auspices of the PALLAS Consortium organised by nine universities in seven EU Member States.
