An Odd Job for a Judge

It's the definitive article that does it - not just any old law reports but <u>The</u> Law Reports. That is the way they have been from 1865 when the five Inns of Court and the Law Society started them. In 1940 a Lord Chancellor's Committee recorded its opinion that the Law Reports were in fact pre-eminent and that, since they received no public subsidy, it was the duty of the legal profession to ensure their adequate support; that if a barrister vouched a report with no further justification than reading a transcript of the judgment he (as they mostly were in those days) abused his right. (*"I wish"* say most of today's judges under their breath.) I got this and a lot more from an article written by Mr Justice McNair to celebrate the centenary of The Law Reports (the capital seems to come and go).

McNair J was one of Gray's two representatives and was appointed Chairman of the Council in 1951. He was the first serving judge to hold that position. Almost all his predecessors had been silks although a number later became judges. There was also a President of the Law Society. Since then a number of judges have been Chairman including the redoubtable Sir Robert Megarry V-C.

It is an odd job for a judge: the day one is Mercantile Judge for Wales.

I have responsibility for 57 people engaged in a business with a turnover of about £5 million per annum. Although every lawyer has heard of our main title and most know of the WLR there are several other highly regarded series including the ICR. We also work closely with *The Times*.

Maintaining the ability to publish to the immutable standard required at a speed relevant to current needs is a constant challenge both to the editorial and administrative side. As our print revenue has declined so we have had to make our way in the electronic world. In 2001 our online revenue was £794,000. In 2010 it was £2,678,000. No prizes for guessing where the future lies.

The sort of problems that face our business are all too well known. Last year we had the difficult task of closing a final salary pension scheme that was impossibly costly to run. Although we are a charity there never has been a subsidy and, nice as it would be for the legal profession to think it their duty to support us, we prefer our products to speak for themselves.

Of course the stimulating thing about challenges is meeting them and in that I have a team which brings intelligence, humour and application to everything it does.

The full Council meets once or twice a year. It is a lively occasion with shrewd questions and valuable contributions but, supported by the twin pillars of Editor and

Secretary, the Executive Committee and Strategy Committee are the driving force. Unpaid (though we still manage coffee and biscuits) the members of the Executive Committee devote an enormous amount of time to the business. The trick is to have a good balance of people. Ever since I have been involved we have had one (vital) judicial heavyweight. At present we are lucky to have the Master of the Rolls. Quite apart from his shrewd advice, he and the Editor practise those high diplomatic skills required to accommodate our house style with (often rather firm) judicial views upon the use of capital letters and other, not to be underrated, grammatical matters.

So here we are, poised to take one of the most exciting steps in our history – the launch of ICLR Online, our first full online service direct to users. For many months work has been going apace to provide you with our products in the way most suited to your needs. Okay I know it sounds a bit of a pushy pitch but see for yourself - any time from 18th October. I'm sure you'll be impressed.
